

Privacy Policy for SpendSense

1. Introduction

Welcome to SpendSense! Your privacy is important to us. This Privacy Policy explains how we collect, use, share, and protect your personal information when you use our expense-tracking app. By downloading or using SpendSense, you agree to the collection and use of information as described here.

2. Information We Collect

- **Personal Information**
 - **Name** and **email address** provided at sign-up.
 - **Voice Transcripts**
 - We process your voice input solely to convert speech into text for our model, and descriptions. We do **not** store raw audio files.
 - **Financial & Transactional Data**
 - Records of your **transactions**, **income**, **expenses**, and **budget** settings.
 - **Usage Metrics for App Improvement & Marketing**
 - Aggregated statistics such as total number of active users and in-app ratings. We do **not** collect device identifiers or detailed analytics beyond these metrics.

3. How We Use Your Information

- **Authentication:** Verify your identity and secure your account.
- **Expense Tracking & Budgeting:** Categorize and display your transactions; help you set and monitor budgets.
- **Voice Command Processing:** Transcribe and interpret your voice inputs to streamline data entry.

- **App Improvement & Marketing:** Analyze aggregated user counts and ratings to enhance features and communicate updates.

4. Data Sharing & Third-Party Services

SpendSense relies on trusted partners to power core functionality:

- **Supabase** hosts and manages your data (transactions, user profiles, budgets).
 - We do **not** sell or rent your personal information to advertisers.
 - Any data shared with third parties is limited to what's necessary for service delivery.

5. Data Retention & Deletion

- **Retention:** We keep your data until you choose to clear it or delete your account.
 - **Deletion:** Upon your request, we will permanently remove your personal information and transaction history from our servers and third-party storage within 30 days.

6. Security Measures

- **Encryption:** All data in transit is protected via HTTPS; sensitive information is encrypted at rest.
 - **Access Controls:** Only authenticated users can view or modify their own data.
 - **Secure Authentication:** User credentials are stored using industry-standard hashing algorithms.

7. Your Rights & Controls

- **Access & Update:** You can view and edit your name, email, transactions, and budgets directly in the app.

- **Opt-Out:** To opt out of marketing communications or aggregated analytics, contact us (see section 9).
 - **Data Deletion:** You may delete your account and data at any time via the app or by contacting us.

8. Children's Privacy

SpendSense is intended for users aged 13 and over. We do not knowingly collect personal information from children under 13. If you believe we have inadvertently done so, please contact us for removal.
